This form has been provided to assist you in lodging an application to be a food vendor at the monthly Corks 2 Forks. Minimum requirements to apply

- A copy of public /product liability insurance certificate to accompany this application
- A copy of food vendor's health licence to accompany this application
- A stall fee of \$200 unpowered and \$250 powered is required within 7 working days of food vendor approval
- Stall fees are GST inclusive and includes 3 free admission passes. Any additional passes will need to be included in your application form and charged at \$5.00 each.
- Food vendors must operate a minimum of 3pm to 8pm at the event
- Current tested and tagged of all electrical equipment including extension leads.

Terms and Conditions for Food Vendor

1. Einstein Events has the final say on the site allocation. No further matter will be entered into.
2. Einstein Events will not under any circumstance be held responsible for any loss of, or damage to, the stock in trade etc. or any part thereof, belonging to any stall holder from any cause whatsoever.
3. Einstein Events will not be responsible for any accident which may be caused through or by the stall holder, or which may happen in connection with his/ her business and stall holder shall save and hold harmless Einstein Events and indemnify it against any legal proceeding arising from such accident
4. The stall holder and/or employees are to conduct themselves in an orderly and respectful manner while they are at Corks 2 Forks. Alcoholic beverages must not be consumed on sites by the stall holder and or employees.
5. Einstein Events reserves the right to forbid the sale of any line for which specific application has not been made.
6. Stall fees include 3 free admission passes. Any additional passes will need to be included in your application form and charged at \$5.00 each.
7. All equipment including electrical leads must be tested and tagged and must not impede the flow of pedestrians or traffic. Use of untagged equipment will not be permitted.
8. All food stalls with cooking facility must provide a current test tagged fire extinguisher or fire blanket.
9. Gas cylinders are to be located in an accessible location should inspection be requested.
10. Each stall is entitled to 2(two) power outlet only. Additional power outlets are charged at an extra \$25.00 each and subject to availability on the day.
11. The use of double adaptors is prohibited, to prevent overloading of circuits
12. Stall must remain operational for the duration of the event as outlined in event schedule. Stall pack down can only commence from finishing time of event unless otherwise approved by event organiser.
13. Site allocation and setup commence times will be provided.
14. It is the responsibility of stall holder to keep their area looking professional, presentable and free of rubbish.
15. All food stalls will be required to handle grey water "sullage" and food wastes in a responsible, legal and environmentally sound manner.
16. All stall holder rubbish must be cleaned up and placed in tidy bags and in bins provided by the event organizer before exiting the event.
17. Grease/oil disposal will not be provided at the event and is the stallholder's responsibility to dispose of.
